Raj: Do we have an idea of the JE scores for qualifying into JE nationals?

David: The Junior National Coaching staff will give us their recommendation and we can approve that or not.

F. Regional Restructuring

- Regions (2,4, & 9) could use some change and these discussions will be very valuable. Perhaps there are some regions that don't need change.
- Region 2, 9, & 4 would like to combine, in some form, into a bigger region.

A straw vote was taken to see if the committee wants a regional restructuring to continue to be discussed.

Straw Vote Results

Yes: 11 No: 2

- Mark: There is a big difference between the regions in terms of size and the amount of money
 we can use. We only have 550 athletes in our entire region. We don't have enough judges.
 The resources that the small regions have are very limited. We are not able to give our athletes
 the same benefits that the rest of the country is getting. By reducing the number of regions, we
 combine resources and can provide better programs for the entire country.
- Bob: As a region that has more things taken away than being provided, I wouldn't necessarily agree with that. This doesn't help us in our area to make things better. Taking away opportunities from one area to give to another doesn't make sense here.
- Tim: What regions feel like they would benefit from restructuring? Perhaps some feel like they are doing fine. Perhaps it's just 2, 9, and 4 that need to be restructuring.

• Jason: This is an amazing discussion. I am trying to put the elite team cup on the back burner and consider the junior program as a whole. By realigning, are we making it easier for kids to stay in their sport.

A straw vote was taken to see if the committee wants to consider more or less regions.

- The committee did not want to consider the option of more regions.
- 9 Votes were in favor of 6, 7 or 8 regions.
- Mark: It seems as though restructuring regions 2, 4 & 9 are supported. We need to see if changes in the east are necessary. We will continue the conversations in the west. Have these conversations in the east.
