- 3) The Online Course, Fundamentals of Gymnastics (still free) will be required for all levels of Coaches Certification after July 31, 2013. Members should also remember to complete and submit the Coaches Certification Pre Placement form that can be found online.
- 4) Remind anyone who is hosting a state or regionals clinic to register the event with the USAG so coaches will get education credit. The status of your membership, educational credit, etc can be found online after you create an account and check the link "My Membership."
