I. Establish the four 2025 Winter Cup Qualifier Competitions

Bids were received from the following competitions:

- Stanford Open
- Washington Open
- Rocky Mountain Open
- Beach Blast Invitational
- Houston National Invitational
- Windy City Open
- West Point Open
- Navy Open

The Committee evaluated competitions by location to ensure each region of the country was accounted for. The college programs prefer using competitions that include a collegiate session as their calendars and budgets are set over a year in advance. Utilizing competitions that are outside of a collegiate meet means added travel expenses and adjusted scheduling.

The Committee agrees that they want to give different competitions an opportunity to host the qualifier competitions, but we will need to establish those decisions earlier so that college programs can incorporate them into their budgets and schedules. We can look to secure Winter Cup qualifier competitions two years in advance at our US Championship meeting annually.

The Committee reviewed each of the bids and decided on the following four competitions to be Winter Cup qualifiers in 2025:

- Stanford Open
- Rocky Mountain Open
- Windy City Open
- West Point Open

Sergei joined the call prior to the next agenda item.

II. The MPC is tasked with vetting the candidates for the two Men's Program Representative positions on the USAG Programs Council.

We have four candidates who have been nominated for the two open positions:

- Rustam Sharipov
- Jorge Valdes
