 - c. The final spot is selected using discretionary criteria. The committee discussed many criteria including: the 2D+E results from Winter Cup and Elite Team Cup, total difficulty, and individual medal potential.

- II. London Open Selection
 - a. The non-traveling reserve athlete from DTB is the first automatic selection

 - b. The next three current Level 10 National Team athletes in rank order using 2D+E results from Winter Cup Day 1 and Elite Team Cup, who were not named to the DTB Team
 - i. Justin Park
 - ii. Divier Ramos
 - iii. Ty Rodriques
 - c. The final team athlete and the non-traveling reserve athlete are selected using discretionary criteria
 - i. Due to the number of athletes injured or unable to participate in Winter Cup or ETC, the committee has decided that the level 10 Junior National Team Members who have not been assigned to a 2025 international competition will have the opportunity to submit competition videos to be judged and evaluated based on discretionary criteria. These videos must be full routines on all six events recorded from a single competition. The videos must be submitted no later than April 28, 2025.
