The main objective of this meeting is to allow Tony Beck and John Robinson to present their proposal for selection processes in selecting the National Team and World Championships Team. The proposal included creating clear benchmarks for attaining National Team and World Team spots through the use of D Score and Final Score targets. These targets could also be used as eligibility criteria for being named to those teams, i.e., an athlete must meet at least one benchmark to be eligible for National Team consideration. By creating minimum standards for eligibility and higher benchmarks for automatic spots, this could alleviate the need for our Bonus system.

The proposal also included the same process for determining the Senior Development Team. However, there were specific D Score and Final Score standards for each single-age year (18, 19, and 20).

The MPC agreed that this was a very impressive proposal but will need further discussion and consideration if it is to be implemented as part of our qualification to Championship events and/or as part of National Team selection.

The next agenda item was to have the VP (Jason) explain that USAG will be hiring Development Program Technical Director for the Men's Program in 2026. This position will oversee all technical related matters within the Development Program and will be especially focused on education for coaches and clubs as well as judge education and certification.

The hiring of this position may lead to the development of a new technical (rules) committee, which may require shifts in the current committee structure within the Men's Program. The MPC will need to be heavily involved in these plans and discussions throughout 2026.

To end the meeting, Jason briefly went over some calendar updates for 2026.
