

Senior National Team Selection 2024 U.S. Championships April 2024

A minimum of 15 athletes will be named to the Men's Senior National Team in the following process:

- The top five athletes by all-around final results from combined 2-day total
- The next five athletes by rank order from the Points Program final results (combined 2day total), not already named to the team
- Remaining spots will be filled by discretionary criteria or petition (outlined below)

A minimum of two and a maximum of five athletes, aged 18-20 years, will be named to the 2024 Senior Development Team through the following process:

- Achieve an all-around FIG D score of 32.0 on at least one day of competition at the 2024 U.S. Championships
- Be the top ranked 18-year old athlete from the Senior competition AA final results (combined 2-day total) that does not make the Senior National Team or meet the D score standard for the Senior Development Team
- In the event that less than two (2) athletes are named to the Senior Development Team by the D score standard, then one (1) athlete will be named to the Senior Development Team by highest D score ranking from either day of competition at the U.S. Championships.
- Any remaining unfilled Senior Development Team spots will go back to the Senior National Team or Senior Development Team and be filled by Discretionary Criteria or petition (outlined below).

Discretionary Criteria (Senior)

The following criteria will be evaluated using results from the 2024 U.S. Championships, including both days of competition and results from the Points Program:

- Team scoring scenarios used for Olympic Games selection
- Rankings within each competition results and Points Program results
- D scores that are competitive with finalists from major FIG international events* in 2022, 2023 and 2024
- E scores that are competitive with finalists from major FIG international events* in 2022, 2023 and 2024

• Overall competitiveness with top international athletes across major FIG international events* in 2022, 2023 and 2024

Petition Process

Petitions are due to the Chair of the designated Selection Committee via email before the conclusion of the 2024 U.S. Championships. In order for petitions to be accepted for review, they must include the following:

- a. Petition form to be completed: <u>https://usagym.org/men/forms/</u>
- b. Medical report/letter subject to verification by USAG medical staff (if applicable)
- c. Athlete's return to play plan/timeline
- d. Proof of medical clearance to participate or estimated date of clearance subject to verification by USAG medical staff

For petitions to the Senior National Team, the designated Selection Committee will consider the discretionary criteria listed above as well as past results from domestic elite championships and FIG international events*.

* Major FIG international events include, but are not limited to the following competitions:

- World Championships
- FIG World Cups and Challenge Cups
- DTB Pokal
- Continental Championships
- Major Games (Olympic Games, Asian Games, Pan Am Games, World University Games, Commonwealth Games, European Youth Olympic Festival, etc.)
