SECTION 1: OVERVIEW

These procedures outline the pathway for nomination to the 2026 Junior World Championships (JWCH) and World Youth Competition (WYC) for USA Gymnastics.

The maximum Team size can be up to twenty (20) pair/groups (Women's Pair, Men's Pair, Mixed Pair, Women's Group, and Men's Group). The SC is not obligated to fill all available spots of the age categories (Youth 12-18 & Junior 13-19) or events.

SECTION 2: SELECTION PROCESS DIAGRAM

The following provides a high-level overview of how athletes will be nominated to the Team:



Note: This diagram is for informational purposes only. In the event of a conflict between the diagram and any written section herein, the written sections will take precedent.

SECTION 3: ATHLETE REQUIREMENTS

1. Nationality/Passports Requirements:
 - Athlete must be a national citizen of the United States at the start of 2026 USA Gymnastics Championships and at the time of nomination.
 - Have a valid United States passport at the time of the 2026 USA Gymnastics Championships that does not expire for six months after the conclusion of the 2026 Junior World Championships and World Youth Competition.
2. Local Organizing Committee (LOC) Requirements:
 - Comply with all rules and policies implemented by the LOC.
3. WGYM (IF) Requirements:
 - Comply with all IF eligibility requirements which will be posted here once available: [Technical Regulations](#)
 - Hold a valid WGYM License at the time of the 2026 JWCH and WYC Nominative Registration.
 - Youth 12-18 athletes must be between 12 and 18 years of age by December 31, 2026 with maximum 6 years age difference between partners.

- Junior 13-19 athletes must be between 13 and 19 years of age by December 31, 2026 with maximum 6 years age difference between partners.
- 4. USA Gymnastics Requirements:
 - Comply with the USA Gymnastics National Team Athlete Agreement.

 - Athlete must have an active USA Gymnastics membership.
 - Athlete does not have an active suspension from the U.S. Center for SafeSport that would make the Athlete ineligible to participate in a sanctioned event.
 - Athlete does not have an active sanction for an anti-doping rule/policy violation that would make the Athlete ineligible to participate in a sanctioned event.
 - Athletes age 18 and over must complete a background screen and US Center for SafeSport education training as required by the USA Gymnastics Safety and Response Policy.
 - An athlete may not be named to the JWCH and WYC Team in multiple disciplines (i.e., men's pair and men's group).
- 5. Other minimum requirements to be eligible for the team
 - Athletes trying out for the JWCH and WYC Team must compete in the age category at the 2026 World Team Trials in which they wish to be considered for team selection.
 - Agree to be bound by and adhere to all IOC, WADA, IF, USADA and USOPC anti-doping protocols, policies and procedures, as applicable. This includes participation in Out-of-Competition Testing and an agreement to be bound to the results management authority of the IOC, WADA, IF, USADA, or other Anti-Doping Organization as applicable.
 - Meet all health and safety protocols, to include vaccine requirements and/or testing requirements set forth by the government, local laws, USOPC, and/or IF.

SECTION 5: SELECTION PROCESS

Provide a step-by-step description of the selection process including an overview of the IF Qualification System.

5.1 TOTAL QUOTA PLACES:

Include information about quota allocation, whether quota spots are awarded by name and/or by country.

- A Maximum of 52 athletes may be selected to the JWCH and WYC Teams, with not more than two (2) pairs or groups per category (age group and event).
- A Maximum of one (1) alternate per category (age group and event).
- Selection Committee is not obligated to fill all available spots on the WAG team.

5.2 EVALUATION EVENT QUALIFICATION PATHWAY:

The qualifying event for selection to the JWCH and WYC team will be the 2026 USA Gymnastics Championships in Tulsa, Oklahoma June 22-27th.

- Pair/groups must meet age eligibility requirements listed in Section 3 and be registered to compete in their respective age category (Youth 12-18 or Junior 13-19) at the 2026 USA Gymnastics Championships to be considered.
- Qualification process to compete at the 2026 USA Gymnastics Championships is outlined in the [Acrobatic Rules & Policies](#)

5.3 NOMINATION TO THE TEAM:

- A pair/group will automatically qualify to the JWCH and WYC team if all the requirements for the automatic qualification are met (see section 6.1)
- Additional pair/groups may be named to the JWCH and WYC team by the Acrobatic Selection Committee based on discretionary selection criteria (see section 6.3).

SECTION 6: SELECTION CRITERIA TO NOMINATE ATHLETES

6.1 AUTOMATIC SELECTION CRITERIA

A pair/group will automatically qualify to the 2026 JWCH and WYC Team at the 2026 USA Gymnastics Championships if *all* the following criteria is met:

- 6.1.1** The pair/ group must finish in first place in qualifications, semi-finals (if applicable), and finals in their respective event. This ranking is determined without the addition of bonus credits.
- 6.1.2** The pair/group must earn minimum scores in each routine in qualifications, semi-finals (if applicable), and finals as follows:
 - 8.75 Artistry
 - 17.5 Execution

- 6.1.3** The pair/ group must achieve minimum difficulty value in each routine in qualifications, semi-finals (if applicable), and finals, as follows:

	BALANCE	DYNAMIC	COMBINED
YOUTH 12-18	90	80	110
JUNIOR 13-19	120	110	165

6.2 RATIONALE FOR UTILIZING DISCRETIONARY SELECTION:

Acrobatic Gymnastics is a subjectively judged event, and a pair/group can be severely penalized for a single error in competition, which may not accurately reflect their complete readiness or proven ability to demonstrate readiness in world-level competition.

6.3 DEFINE THE DISCRETIONARY CRITERIA TO BE USED:

In addition to the automatic qualification to the JWCH and WYC Team, pair/groups may be added to the WAG Team based on the following discretionary evaluation of performances from the 2026 USA Gymnastics Championships. Evaluation criteria for selection are outlined below. Note: Additions via the Petition process will use the discretionary criteria below as well. All criteria are considered equivalent and will be evaluated.

- **Score(s) and ranking(s) from the 2026 Gymnastic Championships.** Note that any received bonus credit(s) are removed prior to score and rank evaluations.
- **Elements Performed.** During the elements performed evaluation process, additional consideration will be given to those pair/groups that compete all routines within a few values, at, or above the respective minimum difficulty values listed below at the 2026 USA Gymnastics Championships.

- Total exercise difficulty will be compared against the target difficulty. Target difficulty is the difficulty score before CJP deductions and prior to any Bonus credit additions.
- Bonus elements and other high-quality elements successfully performed in competition. High-quality elements defined as showcasing difficulty, creativity, or innovative entrance/exits successfully performed in competition.
- Number of elements in each exercise to reach the total difficulty. Skills are combined when logical and possible to maximize flow of routine and minimize number of skill builds.
- Technical performance of elements including quality of body lines, exceptional amplitude and body shapes in balance and dynamic, and overall control and ease of elements. Individual elements are performed cleanly with limited technical deductions.
- **Artistry and presentation**

- Performance, choreography, musicality, Expression, and Partnership will be considered by the SC (per WGYM Acrobatic Gymnastics Code of Points).
- Intricacy, complexity, and creativity of choreography exhibited in exercises.
- Effective use of music, entries/exits, or other artistry moments that create identity or memorability amongst large competitive divisions.
- Overall sophistication and performance of artistry and choreography will be considered. Routines are expected to be performed with full amplitude, polished timing, smooth transitions with elements, and ease on the floor.
- **International caliber and Overall performance**
 - International caliber as defined as strength, endurance, flexibility, and grace. Standards commensurate with world-level competitors.
 - Posture, presence, and poise entering and exiting the floor and during the performance of the exercise.
 - Previous competitive experience in current or past partnerships within the last two (2) years. Pair/group professionalism, and consistency will be taken into consideration.
 - Consistency - Percentage of hit routines at any official international assignment or selection event during the 2024-2026 competitive seasons.
 - A hit routine is defined as a routine that does not include a very large deduction (as defined in the [WGYM Code of Points](#)) on any single skill within the routine.
 - Mental and physical competitive readiness that allows for maximum performance.
 - Demonstrates confidence and consistency in all aspects of training and performance at 2026 USA Gymnastics Championships.
 - Readiness to compete – current health status and physical preparedness of the pair/group.
 - Demonstrated professional attitude and ability to positively contribute to the team dynamic and adhering to National Team policies.
- **Medal Potential –**
 - Consistent ability through two (2) exercises, balance and dynamic to reach a total qualification score strong enough to qualify into JWCH or WYC finals and additionally, the particular strength and international competitiveness of the combined exercise, which is used to determine the combined medalists per the WGYM Junior World Championships and World Youth competition rules.

If after evaluation of the above discretionary criteria two (2) or more pair/groups are considered equal, the Selection Committee will then evaluate national and international competition history from the previous two (2) seasons based on the competition history form submitted upon registration for 2026 Gym Champs (see Attachment A). The Selection Committee will use the criteria below to compare and select the pair/group.

- Number and type of competitions
- Performance and scores from those events
- Consistency from those events

6.4 DEFINE THE PETITION PROCESS

Petition Procedures – Notwithstanding the process identified in the preceding sections of these Selection Procedures, USA Gymnastics recognizes that extraordinary circumstances may occur which would cause a pair/group otherwise deserving of a spot on the 2026 JWCH and WYC Team, because of their previous competition results, to be unable to participate in one or more steps in that process. For a petition onto the JWCH or WYC Team to be considered, it must be submitted in writing to the Director of Acrobatics Program and High Performance Manager and meet the following requirements:

- A. Petitioning athletes must have:
 - i. Qualified to compete at the 2026 USA Gymnastics Championships.
 - ii. Registered to compete at the 2026 USA Gymnastics Championships.
 - iii. Signed and submitted selection procedures by the deadline.
- B. Petitions must be submitted immediately following the pair/group's inability to participate in the selection event and before the conclusion of the selection event.
- C. Petitioning athletes MUST submit a video for review. The video should follow the guidelines listed in G. below.
- D. Petitions will be considered in the event of an injury, illness, family death, or other extenuating circumstances.
 - i. The petition must include the date and nature of the injury and/or illness, family death, or other extenuating circumstance.
 - ii. Petitions based upon injury or illness must be accompanied by a physician's statement. The injury or illness is subject to verification by a physician approved by USA Gymnastics. Additional documentation may be requested to validate unforeseen circumstances.
- E. Due to the interdependent nature of partnerships, a petition must be jointly submitted by all members of the pair/group.
- F. Petitions will be considered by the Acrobatic Gymnastics Selection Committee (SC) based on discretionary criteria listed in 6.3.
- G. Petition Video Guidelines
 - i. All competition videos should be from the judge's viewpoint, as close to a normal judge's position as possible.
 - ii. Perspective should be from the front center of the floor.
 - iii. Recording device set up on table, or on tripod (preferred) slightly above height of table.
 - iv. Camera should be a reasonable distance from the floor and athletes, so all partners are visible, yet athletes do not appear too distant in the video.
 - v. If possible, all four corners of the floor should be visible in the video.
 - vi. The video should be HD quality; standard HD (720 or 1080).
 - vii. The video should be stable, without shaking or bumps. Use of a tripod is helpful.
 - viii. Video should be captured using landscape perspective.

- ix. As much as possible, the camera should remain static. Camera should remain at a steady distance to see all athletes and skills and should only be moved from side-to-side if the entire floor is not visible. The camera should not be moved up and down to capture the routine.
- x. All partners must be visible at all times. This includes for high skills and tosses, as well as when the partners are spread around the floor.
- xi. Video must include the athletes' walk on at the beginning of the exercise, the complete exercise, and the walk off at the end of the exercise.
- xii. Music should be clear and loud enough to hear on the video. Video must consist of all competition routines with all skills, full amount of difficulty, and artistry. Performances must be of the most recent competition or event, ideally within four (4) weeks or less of USA Gymnastics Championships. Competition attire is required.

Note: Coaches are encouraged to precautionarily take videos of performances leading up to 2026 USA Gymnastics Championships in the event a petition would be required.

6.5 SELECTION COMMITTEE

The committee that will be responsible for making discretionary selections or other decisions and recommendations directly impacting athletes in the selection process.

Note: In the event a selection committee member cannot attend the event due to extenuating circumstances, the selection committee will follow guidelines outlined in the selection committee charter for replacement.

SECTION 7: MANDATORY TRAINING AND/OR COMPETITION

Specify the location, schedule, and duration of all mandatory training and/or competition for athletes who are nominated to the Team.

- Pair/groups named to the JWCH and WYC team are expected to continue their training at the same level of intensity, hours of training, and number of days/week to maintain their level of preparation.
- Pair/groups named to the WAG Team are required to attend the JWCH and WYC preparatory training camp August 14-16th, location TBA.
- Per the competition directives, provisional training for Junior World Championships and World Youth Competition dates are as follows: Sept. 15th – Sept. 20st
 - Travel days may be outside of these dates. These dates include one day of early training. All selected pair/groups will be expected to participate in this training

While waivers for mandatory training will not be unreasonably withheld, all athletes nominated to the Team should arrange for appropriate time off from school, work or other obligations in advance. Waivers will primarily be granted for injury or other similar incapacity or for a personal/family emergency. Requests for a waiver must be submitted in writing to the Director of Acrobatics Program as far in advance as possible.

SECTION 8: DATE OF TEAM NOMINATION

The Nomination of athletes, including replacements, will be announced to all athletes on or before June 28th, 2026.

SECTION 9: REMOVAL OF ATHLETES FROM THE TEAM

9.1 NGB JURISDICTION

- a. An athlete who is nominated to the Team by USA Gymnastics may be removed for any of the following reasons, as determined by USA Gymnastics:
 - i. Voluntary withdrawal. Athlete submits a written letter to the USA Gymnastics Chief Programs Officer and the Acrobatic Program Director requesting to voluntarily withdraw from the Team.
 - ii. Injury or illness. Injury or illness that inhibits peak performance, which shall be determined by an examining physician, with medical documentation, verified by USA Gymnastics Medical Staff.
 - iii. Failure to participate. Athlete does not participate in all Mandatory Training and/or Competition as defined in these procedures.
 - iv. Code of Conduct Violation. Athlete violates the [USA Gymnastics Code of Conduct](#).
 - v. Athlete Agreement. Athlete violates a term in their signed [USA Gymnastics National Team Agreement](#).
 - vi. Non-compliance. Athlete does not meet the athlete eligibility requirements listed in Section 3 of these selection procedures.
- b. An Athlete may be removed as a nominee to the Team or from the Team if found to have violated IOC, WADA, IF, USADA and/or USOPC anti-doping protocol, policies and procedures, the U.S. Center for SafeSport Code, the USOPC Athlete Safety Policy and USA Gymnastics Safety and Response policies, as applicable.

- c. Removal may only occur by action of the President of USA Gymnastics and the Acrobatic Athlete Selection Representative (or another Athlete Representative appointed by the USA Gymnastics Athletes' Council in the case of a conflict of interest) after consultation with the Selection Committee, and an interview with the athlete and his coach. An athlete who is removed from the 2026 Championships Team pursuant to this provision has the right to a hearing per [USA Gymnastics Grievance policy](#) and the [USOPC Bylaws](#) (Section 9).

SECTION 10: SELECTION PROCESS IF ATHLETE VACANCY OCCURS PRIOR TO SUBMISSION OF ENTRIES BY NAME TO THE ORGANIZING COMMITTEE

Alternate pair/groups may be selected according to the criteria and events listed in this document. A maximum of one (1) alternate pair/group per event.

- 10.1 Should a vacancy occur prior to submission of Entries by Name to the LOC, the alternate in the respective event will be requested to show full out routine in competitive attire via live zoom for the Selection Committee. The performance will be evaluated for proof-of-readiness based on the discretionary criteria outlined in Section 6.3. The Selection committee may/may not name the alternates as replacements.
- 10.2 All replacement athletes must meet all requirements listed in Section 3.

SECTION 11: SELECTION PROCESS IF ATHLETE VACANCY OCCURS AFTER SUBMISSION OF ENTRIES BY NAME TO THE ORGANIZING COMMITTEE

Alternate pair/groups may be selected according to the criteria and events listed in this document. A maximum of one (1) alternate pair/group per event.

- 11.1 Should a vacancy occur after submission of Entries by Name to the LOC, if allowed, the alternate in the respective event will be requested to show full out routine in competitive attire via live zoom for the Selection Committee. The performance will be evaluated for proof-of-readiness based on the discretionary criteria outlined in Section 6.3. The Selection committee may/may not name the alternates as replacements.
- 11.2 Any replacement of athletes must comply with these selection procedures in addition to WGYM regulations including applicable Late Athlete Replacement (LAR) policies.
- 11.3 All replacement athletes must meet all requirements listed in Section 3.

SECTION 12: RIGHT TO A HEARING

An athlete who is removed from the Team has the right to a hearing per the USA Gymnastics' complaint procedures <https://static.usagym.org/PDFs/About%20USA%20Gymnastics/Governance/grievance.pdf> and the USOPC Bylaws, Section 9 (<https://www.usopc.org/governance/dispute-resolution>).

SECTION 14: DISCLAIMERS

These procedures are based on IF rules and regulations as presently known and understood. Any change in the selection procedures caused by a change in IF rules and regulations will be distributed to the affected athletes immediately. The selection criteria are based on the latest information available to USA Gymnastics.

However, the selection criteria are always subject to unforeseen, intervening circumstances, and realistically may not have accounted for every possible contingency. If any force of nature, pandemic, or force majeure, should cause the alteration or cancellation of any of the selection events listed in this document, these selection procedures may require revisions.

SECTION 15: CONFLICT OF INTEREST

All members of the Selection Committee (Section 6.4) and all individuals who developed these selection procedures (Section 20) must comply with the USA Gymnastics' Conflict of Interest Policy https://static.usagym.org/PDFs/About%20USA%20Gymnastics/Governance/coi_policy.pdf to include completing and submitting a disclosure form consistent with the USA Gymnastics' Conflict of Interest Policy before convening the committee.

SECTION 18: NON-RETALIATION

SECTION 19: SUPPORTING DOCUMENTS

A Selection Committee report outlining the work and decisions of the Committee, will be made available for distribution to all athletes and coaches who participated in the Selection Events at least 14 days before the nominative deadline for the event for which the team is being selected, unless the Selection Committee meeting occurs less than 30 days before the nominative deadline for the event for which the team is being selected, in which case the minutes will be published within a reasonable timeframe after the Selection Committee meeting under the circumstances. The report will be made public on the USA Gymnastics website. USA Gymnastics retains the sole discretion to determine the contents and timing of the report.

APPENDIX B – GLOSSARY

Contingency means a future event or circumstance which is possible but cannot be predicted with certainty.

Delegation Event means the Olympic Games, the Paralympic Games, the Pan American Games, and the Parapan American Games.

Force Majeure means an event or effect that cannot be reasonably anticipated or controlled (e.g., hurricane, tornado, etc.).

Grievance Procedures means the process that enables an athlete to file a complaint with the NGB or USOPC.

Jurisdiction means the power or authority to make decisions and judgments.

Nominated means an athlete, coach or staff member whose name has been submitted to the USOPC by an NGB for participation in a Delegation Event.

Protected Competition means a Delegation Event or a Qualifying Competition.

Qualifying Competition means either of the following:

- i. **NGB Qualifying Competition:** Any competition or activity organized or approved by the NGB where the athlete's performance or results are considered in the published selection criteria to represent the United States in a Delegation Event.
- ii. **International Qualifying Competition:** Any international sport competition where (i) athletes represent the United States against athletes representing other nations, (ii) the NGB officially designates entrants, as required by the competition organizers, and (iii) athlete results or performance are included in the published criteria to qualify, or be selected, to represent the United States in a Delegation Event.
