#### SECTION 1: OVERVIEW

These procedures outline the pathway for selection to the 2025 World Championship Team for Men's Artistic Gymnastics.

The maximum team size can be up to six (6) athletes with a maximum of three (3) athletes per apparatus, per country.

#### SECTION 2: ATHLETE REQUIREMENTS

1. Nationality/Passports Requirements:
  - Have a valid United States passport at the time of the 2025 U.S. Gymnastics Championships that does not expire for six (6) months after the conclusion of the World Championships.
2. Minimum FIG Requirements [if applicable]:
  - Abide by the rules in the FIG including nationality/citizenship requirements.
  - Comply with all rules and policies implemented by the [LOC].
  - Comply with all FIG eligibility requirements found here: <https://www.gymnastics.sport/site/rules/#1>
3. NGB Requirements:
  - Comply with the USA Gymnastics National Team Agreement.
  - Comply with the USA Gymnastics Code of Conduct.
  - Comply with the USA Gymnastics Safety and Response Policy.
  - Athlete must have an active USA Gymnastics membership. Athlete does not have an active suspension from the U.S. Center for SafeSport that would make the Athlete ineligible to participate in the Event.
  - Athlete does not have an active sanction for an anti-doping rule/policy violation that would make the Athlete ineligible to participate in the Event.
4. Anti-Doping Requirements:
  - Agree to be bound by and adhere to all WADA, FIG USADA and USOPC anti-doping protocols, policies and procedures, as applicable. This includes participation in Out-of-Competition Testing and an agreement to be bound to the results management authority of the WADA, FIG, USADA, or other Anti-Doping Organization as applicable. Meet all health and safety protocols, to include vaccine requirements and/or testing requirements set forth by the government, local laws, USOPC, FIG and/or the Local Organizing Committee.

September 17-21, 2025	World Championships Team Camp (petitions only) – USOPTC Colorado Springs, CO

#### SECTION 4: SELECTION PROCESS

Provide a step-by-step description of the selection process including an overview of the FIG Qualification System.

##### 4.1 TOTAL QUOTA PLACES:

2025 World Championships will consist of up to six (6) athletes with a maximum of three (3) athletes per apparatus, per country. This is an individual World Championships, therefore there is no team event. Only all-around and individual event medals will be awarded. Up to three (3) non-traveling reserve athletes will be named.

##### 4.2 EVALUATION EVENT QUALIFICATION PATHWAY:

The 2025 U.S. Gymnastics Championships will be the selection event for the World Championships and is held on August 7-10, 2025. Athletes who are FIG Senior age eligible and U.S. citizens are qualified to the Senior division of the 2025 U.S. Gymnastics Championships, including:

- a. All current Senior National Team & Senior Development Team members
- b. All Senior National Team or Senior Development Team members from the previous two (2) selection events (2025 Winter Cup & 2024 US Championships)
- c. The up to four (4) current Junior National Team members (FIG 18+) who qualified to US Championships via Day 1 all-around results at the 2025 Winter Cup.
- d. The next five (5) non-qualified athletes via [2025 Winter Cup Points Program final results](#) (combined 2-days)
- e. The top two (2) ranked non-qualified athletes in the Level 10 (18+) JE division via final all-around results at the Development Program National Championships (combined 2-days)
- f. The top two (2) ranked non-qualified athletes in the final all-around results at the 2025 NCAA Championships. Athletes must finish in the top 10 in the all-around to be eligible.
- g. All remaining unfilled spots (up to 48) will be filled by either medical petition or by qualifying from the Senior session(s) at the [2025 Men's National Qualifier competition](#)\*

\*Athletes may qualify from the Men's National Qualifier competition by all-around or Points Program results. Half of the unfilled spots will be determined via all-around ranking and half via Points Program ranking. If there are an odd number of spots remaining to be filled for U.S. Gymnastics Championships, then the additional spot will go to the all-around results.

#### 4.3 NOMINATION TO THE TEAM:

To earn an automatic spot on the 2025 World Championship Team at the 2025 U.S. Gymnastics Championships, an athlete must win their apparatus (combined two-day total) and achieve a D score on either day of competition that is equal to or higher than the highest D score on that apparatus from any day of competition at the [2025 European Championships and 2025 Asian Championships](#). In the event of a tie on an event between two (2) athletes, where a tie cannot be broken by [FIG tie-break procedure](#), then a maximum of two (2) athletes may achieve the automatic spot on each apparatus. In the event of a tie on an event between more than two (2) athletes, where a tie cannot be broken by FIG tie-break procedure, then the Senior Selection Committee will use the Discretionary Criteria listed in Section 5.2 to determine the up to two (2) athletes who may achieve automatic spots on that apparatus.

In the event there are less than six (6) athletes that meet these criteria, the remaining selection of up to six (6) total athletes will be conducted by the Senior Selection Committee via Discretionary Criteria in Section 5.2 and/or Petition Process in Section 5.2.

In the event there are more than six (6) athletes that meet these criteria, then the Senior Selection Committee will use the Discretionary Criteria listed in Section 5.2 to select the up to six (6) athletes to be named to the Worlds Team.

Up to three (3) non-traveling replacement athletes will be named by the Senior Selection Committee using the Discretionary Criteria listed in Section 5.2.

## SECTION 5: DISCRETIONARY CRITERIA TO NOMINATE ATHLETES

#### 5.1 RATIONALE FOR UTILIZING DISCRETIONARY SELECTION:

The sport of gymnastics is a subjectively judged sport. The objective for the Men's Team is to achieve the highest possible results and win multiple medals. Assessments must be performed to identify an athlete's ability to contribute to the objectives. Multiple factors will play a role when determining the best combination of athletes to achieve the stated objectives.

#### 5.2 DEFINE THE DISCRETIONARY CRITERIA TO BE USED:

To be considered for a spot on the 2025 World Championship Team via Discretionary Criteria, an athlete must finish in the top three (3) in either the all-around (combined two-day total) or on an individual event (combined two-day total) at the 2025 U.S. Gymnastics Championships.

Athletes who qualify through the processes listed above will be considered by the Senior Selection Committee (SSC) using all the factors outlined below, in no priority order:

- Ability to win a medal in an individual final - using results from the athlete's two (2) most recent elite domestic championship competitions (Winter Cup or US Championships) or USA Gymnastics officially assigned FIG international competitions in 2025, the athlete has demonstrated **FIG** final scores **(without exponential bonus)** that would rank in the top three (3) in the all-around or individual event finals from previous FIG sanctioned international events in 2025, including but not limited to the following: FIG World Cups and World Challenge Cups, European Championships and Asian Championships.
- Ability to make an individual final – using results from the athlete's two (2) most recent elite domestic championship competitions (Winter Cup or U.S. Gymnastics Championships) or USA Gymnastics officially assigned FIG international competitions in 2025, the athlete has demonstrated **FIG** final scores **(without exponential bonus)** that would rank in the top eight (8) finalists in the all-around or on an individual event in qualifications from previous FIG sanctioned international events in 2025, including but not limited to the following: FIG World Cups and World Challenge Cups, European Championships and Asian Championships.
- Difficulty Scores – using results from the athlete's two (2) most recent elite domestic championship competitions (Winter Cup or U.S. Gymnastics Championships) or USA Gymnastics officially assigned FIG international competitions in 2025, athlete has demonstrated a Difficulty Score (D score) on an individual event that would rank in the top eight (8) finalists on an individual event in qualifications from previous FIG sanctioned international events in 2025, including but not limited to the following: FIG World Cups and World Challenge Cups, European Championships and Asian Championships.

#### 5.3 DEFINE THE PETITION PROCESS:

If an athlete is injured, ill, or there is an extenuating circumstance that prevents the athlete from completing the selection process, they may submit a petition to the SSC to be named directly to the Worlds Team. Petitions will only be considered if the athlete has competed at least once in 2025 at either a domestic elite championship competition (Winter Cup or US Championships) or a FIG international competition. The SSC will utilize the Discretionary Criteria above. If an athlete has not competed at any of the required competitions stated above in 2025, then their petition will not be considered by the SSC.

If a petition is approved, the athlete will be named to the 2025 Worlds Team but will be required to show routines at the World Championships Preparation Camp (September 17-21) for final confirmation. The athlete must be medically cleared to participate at the camp, which shall be determined by an examining physician verified by USA Gymnastics Medical Staff. Routines will be judged and must demonstrate the following:

- Ability to perform full routines on a competition surface at a level that warranted being named to the Team via Discretionary Criteria

#### 5.4 SELECTION COMMITTEE

The committee that will be responsible for making discretionary selections or other decisions and recommendations directly impacting athletes in the selection process.

a. An independent Observer of Procedure appointed by a sub-committee of the USA Gymnastics Board of Directors will be present at the final selection meeting. (No voice, no vote).

## SECTION 6: MANDATORY TRAINING AND/OR COMPETITION

- All 2025 World Championship Team members must participate in a mandatory training camp at the USOPTC in Colorado Springs, CO. The dates of the camp are September 17-21, 2025. In the event there is an approved petition, that athlete(s) will be required to perform routines that meet the criteria laid out in Section 5.3.
- All 2025 World Championship Team members must participate in the Worlds pre-camp in Funabashi, Japan. The dates are October 11-14 (TBC). The team will travel to Indonesia from Japan.

## SECTION 7: DATE OF TEAM NOMINATION

USA Gymnastics will nominate the Team, including any replacements/alternates after the conclusion of the final day of competition at the 2025 U.S. Gymnastics Championships, on or before August 10, 2025.

## SECTION 8: REMOVAL OF ATHLETES FROM THE TEAM

### 8.1 USA GYMNASTICS JURISDICTION

- a. An athlete who is nominated to the Team may be removed for any of the following reasons, as determined by USA Gymnastics:
- i. Voluntary withdrawal. Athlete submits a written letter to USA Gymnastics Chief Programs Officer and Vice President of Men's Program requesting to voluntarily withdraw from the Team.
  - ii. Injury or illness. Injury or illness which inhibits peak performance which shall be determined by an examining physician verified by USA Gymnastics Medical Staff.

- iii. Failure to participate. Athlete does not participate in all Mandatory Training and/or Competition as defined in these procedures.
  - iv. Code of Conduct Violation. Athlete violates the USA Gymnastics Code of Conduct: <https://usagym.org/about/governance/>
  - v. Athlete Agreement. Athlete violates a term in their signed USA Gymnastics National Team Agreement.
  - vi. Non-compliance. Athlete does not meet the athlete eligibility requirements listed in Section 2 of these selection procedures.
- b. An Athlete may be removed as a nominee to the Team or from the Team if found to have violated WADA, FIG, USADA and/or, the U.S. Center for SafeSport Code and the USA Gymnastics Safety and Response Policy, as applicable.
  - c. Reclassification by the FIG such that the athlete's qualifying performance would not have qualified them for the Team.

#### **SECTION 9: SELECTION PROCESS IF ATHLETE VACANCY OCCURS PRIOR TO SUBMISSION OF ENTRIES BY NAME TO THE LOCAL ORGANIZING COMMITTEE**

- 9.1 Should a vacancy occur prior to submission of Entries by Name to the Local Organizing Committee, the Senior Selection Committee will name a replacement from the list of eligible non-traveling replacement athletes.
- 9.2 All replacement athletes must meet all requirements listed in Section 2.

#### **SECTION 10: SELECTION PROCESS IF ATHLETE VACANCY OCCURS AFTER SUBMISSION OF ENTRIES BY NAME TO THE LOCAL ORGANIZING COMMITTEE**

- 10.1 Should a vacancy occur after submission of Entries by Name to the Local Organizing Committee, if allowed, the Senior Selection Committee will name a replacement from the list of eligible non-traveling replacement athletes.
- 10.2 All replacement athletes must meet all requirements listed in Section 2.

#### **SECTION 11: RIGHT TO A HEARING**

An athlete who is removed from the Team has the right to a hearing per the USA Gymnastics' Opportunity to Participate procedures <https://static.usagym.org/PDFs/About%20USA%20Gymnastics/Governance/grievance.pdf> and the USOPC Bylaws (applies only for a Protected Competition), Section 9 (<https://www.usopc.org/governance/dispute-resolution>).

#### SECTION 12: REQUIRED DOCUMENTS

The following documents are required to be signed by an athlete as a condition of nomination to the Event:

- USA Gymnastics National Team Agreement

#### SECTION 13: DISCLAIMERS

These procedures are based on FIG rules and regulations as presently known and understood. Any change in the selection procedures caused by a change in FIG rules and regulations will be distributed to the affected athletes immediately. The selection criteria are based on the latest information available to USA Gymnastics.

However, the selection criteria are always subject to unforeseen, intervening circumstances, and realistically may not have accounted for every possible contingency. If any force of nature, pandemic, or force majeure, should cause the alteration or cancellation of any of the selection events listed in this document, these selection procedures may require revisions.

#### SECTION 14: CONFLICT OF INTEREST

All members of the Selection Committee (Section 5.3) and all individuals who developed these selection procedures (Section 19) must comply with the USA Gymnastics Conflict of Interest Policy, to include completing and submitting a disclosure form consistent with the USA Gymnastics Conflict of Interest Policy before convening the committee.

A conflict of interest exists when a personal, family, financial, professional, club, team or business relationship or interferes with, or maybe perceived to interfere with a committee member's ability to be impartial and participate in the selection process in a fair and impartial manner. Any member of the Selection Committee who has an actual, possible, or perceived conflict of interest must disclose it to the USA Gymnastics' Ethics & Grievance Committee prior to the start of the selection process and may be required to recuse themselves from the Selection Committee discussions and/or voting.

If a conflict exists, the USA Gymnastics' Ethics & Grievance Committee shall review the conflict and determine the committee member's level of involvement (e.g., whether that committee member must recuse themselves from participating in discussions and/or voting).

During its review, the USA Gymnastics Ethics & Grievance Committee may ask a Selection Committee member or an affected person for more information at its discretion. For example, if a Selection Committee member is required to recuse themselves from voting, the USA Gymnastics Ethics & Grievance Committee may still determine that a Selection Committee member who has relevant and necessary information related to athlete performance, such as a national team coach or high performance director, may, if requested by the Selection Committee, provide that

information to the Selection Committee if the information is provided in a fair and unbiased manner and if the Selection Committee member with the conflict of interest does not vote toward the final decision.

Additionally, any person with a good faith belief that a committee member has a conflict of interest may report the alleged conflict of interest to the USA Gymnastics Ethics & Grievance Committee ([eandg@usagym.org](mailto:eandg@usagym.org)). Reports may also be made anonymously through the [USOPC's Integrity Portal](#). No committee member shall retaliate in any way against a person who, in good faith, reports an alleged conflict of interest. In addition, the USOPC maintains a strict no retaliation policy that prohibits any employee, contractor, agent, volunteer, or member of the USOPC to take or threaten to take any action against an athlete for reporting information to or seeking assistance from the Office of the Athlete Ombuds.

Any recused individual shall be replaced in accordance with the Men's Senior Selection Committee appointment process.

#### SECTION 17: NON-RETALIATION

The USOPC and NGB have zero tolerance for retaliation against people who make good faith reports of potential ethical, policy, or legal violations, or who cooperate with investigations of those reports. That means no USOPC or USA Gymnastics staff, Board or Committee member, or volunteer may threaten, harass, discriminate against, or take any negative employment or related action (e.g., discharge, demotion, suspension, negative review) on that basis.

#### SECTION 18: SUPPORTING DOCUMENTS

NGB will retain the approved Selection Procedures and all supporting documents, including scouting or evaluation forms, etc., and data from the selection process as required by the NGB's Records Retention Policy.

A Senior Selection Committee (SSC) report signed by the Independent Observer, outlining the work and decisions of the SSC, will be made available for distribution to all athletes and coaches who participated in the Selection Events at least 14 days before the nominative deadline for the event for which the team is being selected, unless the Selection Committee meeting occurs less than 30 days before the nominative deadline for the event for which the team is being selected, in which case the minutes will be published within a reasonable timeframe after the Selection Committee meeting under the circumstances. The report will be made public on the USA Gymnastics website. USA Gymnastics retains the sole discretion to determine the contents and timing of the report.

#### APPENDIX B – GLOSSARY

**Contingency** means a future event or circumstance which is possible but cannot be predicted with certainty.

**Delegation Event** means the Olympic Games, the Olympic Winter Games, the Paralympic Games, the Paralympic Winter Games, the Pan American Games, and the Parapan American Games.

**Force Majeure** means an event or effect that cannot be reasonably anticipated or controlled (e.g., hurricane, tornado, etc.).

**Grievance Procedures** means the process that enables an athlete to file a complaint with the NGB or USOPC.

**Jurisdiction** means the power or authority to make decisions and judgments.

**Nominated** means an athlete, coach or staff member whose name has been submitted by the Selection Committee to the NGB.

**Protected Competition** means a Delegation Event or a Qualifying Competition.

**Qualifying Competition** means either of the following:

- i. **NGB Qualifying Competition:** Any competition or activity organized or approved by the NGB where the athlete's performance or results are considered in the published selection criteria to represent the United States in a Delegation Event.
- ii. **International Qualifying Competition:** Any international sport competition where (i) athletes represent the United States against athletes representing other nations, (ii) the NGB officially designates entrants, as required by the competition organizers, and (iii) athlete results or performance are included in the published criteria to qualify, or be selected, to represent the United States in a Delegation Event.

**Selected** means an athlete, coach or staff member whose name has been submitted by the NGB to the LOC at the final submission date, as determined by the LOC.

For Protected Competitions, USOPC's DRU oversees the administration of dispute resolution services to athletes and other members of NGBs for grievances under the USOPC's jurisdiction to ensure the complaints are heard in a timely and fair manner. ##### **USOPC ETHICS AND COMPLIANCE**

USOPC's Ethics and Compliance team is responsible for ensuring the USOPC and NGBs comply with the Ted Stevens Olympic and Amateur Sports Act, their own bylaws and policies, and any other applicable laws or regulations.
