SECTION 1: OVERVIEW

These procedures outline the pathway for nomination to the 2026 Senior World Championships for USA Gymnastics.

The Team size can be a minimum of two (2) and a maximum of three (3) female athletes; the number of individuals named to the Team will correspond to the team objectives for the World Championships which are listed in Section 6. The team's best chance at meeting those objectives will be with two gymnasts each competing four events. A non-traveling replacement athlete will be named in addition to the officially-named individuals.

SECTION 2: ATHLETE REQUIREMENTS

1. Nationality/Passports Requirements:
 - Have a valid United States passport at the time of the USA Gymnastics Championships that does not expire for six (6) months after the conclusion of the 2026 World Championships.
2. Local Organizing Committee (LOC) Requirements:
 - Comply with all rules and policies implemented by the LOC.
3. (IF) Requirements:
 - Comply with all World Gymnastics eligibility requirements which will be posted here once available: https://www.gymnastics.sport/publicdir/rules/files/en_1.1%20-%20Technical%20Regulations%202026.pdf
4. USA Gymnastics Requirements:
 - Comply with the USA Gymnastics National Team Athlete Agreement. https://static.usagym.org/PDFs/Pressbox/selection/2526_natlteam_agreement.pdf
 - Comply with the USA Gymnastics Code of Conduct https://static.usagym.org/PDFs/About%20USA%20Gymnastics/code_ethical_conduct.pdf
 - Comply with the USA Gymnastics Safety and Response Policy <https://static.usagym.org/PDFs/safesport/policy2025.pdf>
 - Athlete must have an active USA Gymnastics membership.
 - Athlete does not have an active suspension from the U.S. Center for SafeSport that would make the Athlete ineligible to participate in a sanctioned event.
 - Athlete does not have an active sanction for an anti-doping rule/policy violation that would make the Athlete ineligible to participate in a sanctioned event.
 - Athletes age 18 and over must complete a background screen and US Center for SafeSport education training as required by the USA Gymnastics Safety and Response Policy.
 - Comply with Rhythmic National Team Handbook

5. Other minimum requirements to be eligible for the team
 - Agree to be bound by and adhere to all IOC, WADA, IF, USADA and USOPC anti-doping protocols, policies and procedures, as applicable. This includes participation in Out-of-Competition Testing and an agreement to be bound to the results management authority of the IOC, WADA, IF, USADA, or other Anti-Doping Organization as applicable.
 - Meet all health and safety protocols, to include vaccine requirements and/or testing requirements set forth by the government, local laws, USOPC, and/or IF.

SECTION 4: SELECTION PROCESS

Provide a step-by-step description of the selection process including an overview of the IF Qualification System.

4.1 TOTAL QUOTA PLACES:

Each NF has the right to participate with 2 or 3 Individual gymnast(s).

Each NF has the right to choose the number of routines to be performed by its gymnast(s).

Each NF has the right to choose the apparatus to be performed by its gymnast(s).

Each gymnast must perform at least one (1) routine. The minimum number of routines per gymnast is 1 and the maximum is 4 routines. The maximum number of routines per NF is 8 in total, i.e. two (2) routine per apparatus. The number of individuals named to the Team will correspond to the team objectives for the World Championships which are listed in Section 6. The team's best chance at meeting those objectives will be with two gymnasts each competing four events. A non-traveling replacement athlete will be named in addition to the officially-named individuals.

4.2 EVALUATION EVENT QUALIFICATION PATHWAY:

USA Gymnastics Championships is the qualifying event for the SR World Championships.

Qualification to USA Gymnastics Championships is outlined in the Rhythmic Rules and Policies, Chapter 3:

- A. Qualification to the USA Gymnastics Championships
 - 1. Qualifying numbers will be set by USA Gymnastics.
 - 2. Qualification from the Elite Qualifier, with the following pre-qualified exemptions:
 - i. Any current Senior National Team gymnasts unable to compete at the Elite Qualifier due to injury or illness verified by a doctor, extenuating circumstance verified by the Vice President of the Rhythmic Program, or with conflicting international assignments, may advance to the USA Gymnastics Elite Championships.
 - 1) Any gymnast who meets the above criteria and chooses not to compete at the Elite Qualifier must notify USA Gymnastics within four weeks of the Elite Qualifier.
 - ii. The top 6 all-around Senior individuals from the Rhythmic Challenge will automatically qualify to the USA Gymnastics Elite Championships.
 - iii. Any current Senior National Team gymnasts unable to compete at the Elite Qualifier due to injury or illness verified by a doctor, extenuating circumstance verified by the Vice President of the Rhythmic Program, or with conflicting international assignments, may advance to the USA Gymnastics Elite Championships.
 - 1) Any gymnast who meets the above criteria and chooses not to compete at the Elite Qualifier must notify USA Gymnastics within four weeks of the Elite Qualifier.

Gymnasts competing in the USA Gymnastics Elite Championships must be citizens of the United States. Gymnasts who have a World Gymnastics license for another country or have represented another country in international competition, regardless of citizenship (Foreign Athletes), who are ineligible to represent the United States at the Olympic Games, may not participate in the USA Gymnastics Elite Championships.

Gymnasts who hold a current World Gymnastics license for another country may not participate in any session of the USA Gymnastics Championships.

Petitions due to injury, illness, or extenuating circumstances to the USA Gymnastics Championships are only accepted for current National Team members Injury petition: <https://usagym.org/rhythmic/forms/> Petitions must be submitted to the Vice President of the Rhythmic Program for approval by the Rhythmic Program Committee.

4.3 NOMINATION TO THE TEAM:

Automatic bid to the World Team: if a gymnast wins the All-Around and wins at least two of the four event titles at the 2026 USA Gymnastics Championships, she will automatically be named to the team with the second team member named using Discretionary Criteria.

If no gymnast achieves an automatic nomination, all gymnasts will be named using Discretionary criteria in 5.2.

SECTION 5: DISCRETIONARY CRITERIA TO NOMINATE ATHLETES

5.1 RATIONALE FOR UTILIZING DISCRETIONARY SELECTION:

Rhythmic Gymnastics is a subjectively judged event, and an athlete can be severely penalized for a single error in individual competition, which may not accurately reflect her complete readiness or proven ability to demonstrate readiness in world-level competition.

5.2 DEFINE THE DISCRETIONARY CRITERIA TO BE USED:

Selection criteria considered in the following order:

- Readiness to compete—current health status and physical preparedness of each gymnast
- The ability of each athlete to meet the objective for the SR World Championships: Finish in the top 8 AA and top 12 AA respectively.
- Results from 2026 international events officially assigned by USA Gymnastics and the 2026 USA Gymnastics Championships (unless otherwise assigned to a conflicting international event at the same time); analysis of international results will include an evaluation of the strength of the competitive fields (the technical level presented by the top-ranked athletes and by the direct competitors of USA) in relation to the overall objective.
- World Class presentation: the strength, endurance, technical execution standard and artistic components commensurate with World presentation
- Previous proven national results in 2026, if determinative
- Previous proven World Championships results from 2025, if available and/or determinative (a medal or a finalist—AA or Event—at a JR or SR World Championships or SR World Cup)

5.3 DEFINE THE PETITION PROCESS

If an athlete is injured, ill, or there is an extenuating circumstance that prevents the athlete from completing the selection process, such as an international assignment that directly conflicts with the Championships, she may submit a petition to the selection committee by the end of USA Gymnastics Championships to be named directly to the SR World Championships Team. Petitions will only be considered for a current Senior National Team member who have officially represented the country internationally in 2026. The selection committee will utilize the Discretionary Criteria above.

5.4 SELECTION COMMITTEE

The committee that will be responsible for making discretionary selections or other decisions and recommendations directly impacting athletes in the selection process.

SECTION 6: MANDATORY TRAINING AND/OR COMPETITION

Specify the location, schedule, and duration of all mandatory training and/or competition for athletes who are

nominated to the Team.

Training camp in Frankfurt, GER 4 days prior to the start of the World Championships.

While waivers for mandatory training will not be unreasonably withheld, all athletes nominated to the Team should arrange for appropriate time off from school, work or other obligations in advance. Waivers will primarily be granted for injury or other similar incapacity or for a personal/family emergency. Requests for a waiver must be submitted in writing to the Rhythmic Vice President as far in advance as possible.

SECTION 7: DATE OF TEAM NOMINATION

The Nomination of athletes, including replacements, will be announced to all athletes by: June 30, 2026.

SECTION 8: REMOVAL OF ATHLETES FROM THE TEAM

8.1 NGB JURISDICTION

- a. An athlete who is nominated to the Team by USA Gymnastics may be removed for any of the following reasons, as determined by USA Gymnastics:
 - i. Voluntary withdrawal. Athlete submits a written letter to the USA Gymnastics Chief Programs Officer and the Rhythmic Program Vice President/Director requesting to voluntarily withdraw from the Team.
 - ii. Injury or illness. Injury or illness that inhibits peak performance, which shall be determined by an examining physician, with medical documentation, verified by USA Gymnastics Medical Staff.
 - iii. Failure to participate. Athlete does not participate in all Mandatory Training and/or Competition as defined in these procedures.
 - iv. Code of Conduct Violation. Athlete violates the [USA Gymnastics Code of Conduct](#).
 - v. Athlete Agreement. Athlete violates a term in their signed [USA Gymnastics National Team Agreement](#).
 - vi. Non-compliance. Athlete does not meet the athlete eligibility requirements listed in Section 2 of these selection procedures.
- b. An Athlete may be removed as a nominee to the Team or from the Team if found to have violated IOC, WADA, IF, USADA and/or USOPC anti-doping protocol, policies and procedures, the U.S. Center for SafeSport Code, the USOPC Athlete Safety Policy and USA Gymnastics Safety and Response policies, as applicable.
- c. Removal may only occur by action of the President of USA Gymnastics and the Rhythmic Athlete Selection Representative (or another Athlete Representative appointed by the USA Gymnastics Athletes' Council in the case of a conflict of interest) after consultation with the Selection Committee, and an interview with the athlete and his coach. An athlete who is removed from the 2026 World Championships Team pursuant to this provision has the right to a hearing per [USA](#)

SECTION 9: SELECTION PROCESS IF ATHLETE VACANCY OCCURS PRIOR TO SUBMISSION OF ENTRIES BY NAME TO THE ORGANIZING COMMITTEE

9.1 Should a vacancy occur prior to submission of Entries by Name to the LOC, the replacement athlete will fill the vacancy.

9.2 All replacement athletes must meet all requirements listed in Section 2.

SECTION 10: SELECTION PROCESS IF ATHLETE VACANCY OCCURS AFTER SUBMISSION OF ENTRIES BY NAME TO THE ORGANIZING COMMITTEE

10.1 Should a vacancy occur after submission of Entries by Name to the LOC, if allowed, the Athlete Selection Committee will name one of the gymnasts already named to the Team to fill the vacant event or, if an All-Around position is vacant, the replacement athlete will fill the vacancy.

10.2 Any replacement of athletes must comply with these selection procedures in addition to World Gymnastics regulations including applicable Late Athlete Replacement (LAR) policies.

10.3 All replacement athletes must meet all requirements listed in Section 2.

SECTION 11: RIGHT TO A HEARING

An athlete who is removed from the Team has the right to a hearing per the USA Gymnastics' complaint procedures <https://static.usagym.org/PDFs/About%20USA%20Gymnastics/Governance/grievance.pdf> and the USOPC Bylaws, Section 9 (<https://www.usopc.org/governance/dispute-resolution>).

SECTION 12: REQUIRED DOCUMENTS

The following documents are required to be signed by an athlete as a condition of nomination to the Team:

SECTION 13: DISCLAIMERS

These procedures are based on IF rules and regulations as presently known and understood. Any change in the selection procedures caused by a change in IF rules and regulations will be distributed to the affected athletes immediately. The selection criteria are based on the latest information available to USA Gymnastics.

However, the selection criteria are always subject to unforeseen, intervening circumstances, and realistically

may not have accounted for every possible contingency. If any force of nature, pandemic, or force majeure, should cause the alteration or cancellation of any of the selection events listed in this document, these selection procedures may require revisions.

SECTION 14: CONFLICT OF INTEREST

All members of the Selection Committee (Section 5.4) and all individuals who developed these selection procedures (Section 19) must comply with the USA Gymnastics' Conflict of Interest Policy https://static.usagym.org/PDFs/About%20USA%20Gymnastics/Governance/coi_policy.pdf to include completing and submitting a disclosure form consistent with the USA Gymnastics' Conflict of Interest Policy before convening the committee.

SECTION 17: NON-RETALIATION

The USOPC and USA Gymnastics have zero tolerance for retaliation against people who make good faith reports of potential ethical, policy, or legal violations, or who cooperate with investigations of those reports. That means no USOPC or USA Gymnastics staff, Board or Committee member, or volunteer may threaten, harass, discriminate against, or take any negative employment or related action (e.g., discharge, demotion, suspension, negative review) on that basis.

SECTION 18: SUPPORTING DOCUMENTS

USA Gymnastics will retain the approved Selection Procedures and all supporting documents from the selection process.

A Selection Committee report signed by the Independent Observer, outlining the work and decisions of the Committee, will be made available for distribution to all athletes and coaches who participated in the Selection Events at least 14 days before the nominative deadline for the event for which the team is being selected, unless the Selection Committee meeting occurs less than 30 days before the nominative deadline for the event for which the team is being selected, in which case the minutes will be published within a reasonable timeframe after the Selection Committee meeting under the circumstances. The report will be made public on the USA Gymnastics website. USA Gymnastics retains the sole discretion to determine the contents and timing of the report.

APPENDIX B – GLOSSARY

Contingency means a future event or circumstance which is possible but cannot be predicted with certainty.

Delegation Event means the Olympic Games, the Paralympic Games, the Pan American Games, and the Parapan American Games.

Force Majeure means an event or effect that cannot be reasonably anticipated or controlled (e.g., hurricane, tornado, etc.).

Grievance Procedures means the process that enables an athlete to file a complaint with the NGB or USOPC.

Jurisdiction means the power or authority to make decisions and judgments.

Nominated means an athlete, coach or staff member whose name has been submitted to the USOPC by an NGB for participation in a Delegation Event.

Protected Competition means a Delegation Event or a Qualifying Competition.

Qualifying Competition means either of the following:

- i. **NGB Qualifying Competition:** Any competition or activity organized or approved by the NGB where the athlete's performance or results are considered in the published selection criteria to represent the United States in a Delegation Event.
- ii. **International Qualifying Competition:** Any international sport competition where (i) athletes represent the United States against athletes representing other nations, (ii) the NGB officially designates entrants, as required by the competition organizers, and (iii) athlete results or performance are included in the published criteria to qualify, or be selected, to represent the United States in a Delegation Event.
