Judges Courses Offered-

JO Judging Courses:

1. will be offered in the Fall and at National Congress .
2. The Spring course option will be eliminated due to rule changes always pending for the following year.
3. JO Judges Course will be offered at the 2010 Visa Championships.
4. RAC Technical reps will meet @ Visa prior to the JO Course for the Instructor's Course
  - a. Course instructors include: RAC Tech Reps, Nat. Judges Rep, JOTC members.
5. 2011 Judges Course will be at the Rhythmic (only) venue ARTT: Arco, Rhythmic & Tramp/Tumbling

National Judges Selection Committee will again assign un-affiliated meet referees for all Regional Championships 2010.

RJC's (regional judging coordinators) are encouraged to assign a balanced panel of judges for all State and Regional Championships.

  - a. Each region will have 20 spots.
  - b. All participants must qualify by score at their regional championships.

Current Competition/Judging Problem:

Competitions are running overtime and judges are performing too many routine judgements per day.

1. Routine Judgments allowed are determined by the number of panels available:  
240 routines per day: 2.5minutes/routine=double panel of judges  
180 routines per day: 3.75 minutes /routine=single panel of judges
2. Judges are paid hourly for the length of the meet.  
Starting with session 1 and ending with the last session of the day.  
Deduct a lunch break of 30 minutes.

\*New Business:

- Offer a coaches symposium at the JO Compulsory Event.
- Create a committee for educational material development.
