### Article 9 – Regional Judging Coordinator

- 9.02 delete (B) & (C)
- add: selection of judges for state meets in consultation with the regional chair
- add: selection of judges for regional meets in consultation with the meet ref and the regional chair when needed.
- update: (D) send updated list of judges status to Regional Chair, Zone Tech Rep, Judges Rep.

#### 2. Events

- a. Rhythmic summit in alternating years when there is no national judging course offered.
  - Present service awards
  - Rhythmic session of experts
  - · Judging critique sessions

## b. Scheduling/Timing of meets-

### Regional meets

- Limiting entries based on numbers and days for event.
- Dividing levels into two different meets to allow more entries
- D1/D2 forms
  - a. Required copies- meet directors should require the minimum number based on the judging panel.

- b. D1/D2 Forms should not be required more than one week prior to the competition.
- 3. Regional Meet Referees:
  - Meet Referees will be assigned by the regional board.
  - Meet Referees should remain on site for the entire meet and should plan to travel the following morning if necessary.
  - Meet Referee must be unaffiliated and have a National rating.
- 4. Responsibilities of the MR.
  - Verify meet Schedule
  - Assign the event panels
  - Meet Referees should be expected to supervise both panels and not be assigned to judge.

## 5. JO Program –

- a. Initial Proposal: Level 3 & 4's perform only two events per competition. Not supported by the JOTC and denied by the RAC.
- b. Level 5's / Level 6's- -will continue to attend a Classics National Championship with a more open qualification format.
- c. Clarification of citizenship status
  - an athlete's citizenship does not come into play under the JO Championship meet format.
  - Part 2 Section 1: non-citizen clause must be revised under (B.) competition format- JO championships.
- 6. In 2011 Compulsory Music & Choreography clarifications -

## Club Music for Levels 4/5

- Clubs may use a different music for age divisions : Child and Junior/Senior Club Compulsory routines for levels 3-5
  - Club routines may have slight variations in choreography for Child and Junior/Senior age divisions.
- 7. Sanction violation procedures- will be revised and posted to the R&P.
- 8. Score Inquiries

Allow Level 7-10 inquiries regarding D1 only starting at Regional Championships and move the inquiry section (found in awards) to the competition format section of the R&P.

- 9. Level 3 Achievement ribbons
  - a. A single achievement ribbon for each event performed for all gymnasts.
    - Blue ribbon for scores between 6.0-10.0
    - Red ribbon for scores between 1.0-5.9..

## 10. JO Championships

- Name change: JO Compulsory Championships will now officially be called the Rhythmic Open Championships (Levels 4-6 Nationals). Approved 11/15/10
- JO Optional Championships will not accept petitions for Level 7/8.
