- A. Recommendation to all Regional Administrative Committees: In order to accommodate growing numbers of participating athletes, Regional and State Championships should begin to split into upper and lower level events. (ex: Level 3-4, Level 5-6, or Level 3-6, Level 7-10)
- B. Recommendation to the National Judges Selection Committee: The coaching community would like to see an increase in the numbers of judges used for the Junior Olympic Championships. The regions would finance the cost of adding an additional panel of four judges.
- C. Proposal to award at the Regional Championships the "Athlete of the Year" and "Coach of the Year" for each Level 4-10. This award is given to the athlete with the highest overall All-Around score regardless of age group and her coach.

D. Proposal to award annually a Regional Service Award by vote of the Regional Committee.

E. Proposal to set the 2018 maximum entry fees for State and Regional events:

Level 3-4 \$75 Level 5-6 \$100 Level 7-10 \$125

F. Proposal to require the use of Level 9 D forms at Regional qualifying events when using a single panel of four judges. (2D, 2A/T) The Regional Committee can eliminate the use of D forms at the Regional qualifying event only when using a full single panel of eight judges and all parts of the score are averaged. (2-D 1/2, 2-D 3/4, 2 A, 2 T)

Proposal for all sanctioned events leading up to the Regional Championships- Score forms for Levels 3-6 and D forms for Level 7-10 will be given back the coach at the conclusion of each meet. Recommending the protocol outlined in the 2016 minutes.

H. Proposal to allow the Regional Committees to set the annual invitational rebate prior to the start of each season. The percentage derived from the total entry fees will be determined by a vote of the Regional Committee. Each region will take into consideration its own financial commitments and initiatives for the year. This rebate can range between 5% and 10% with a cap of \$5000. This information should be posted for meet directors by November 1st.

I. Proposal to set the regulations for Foreign Brevet judges when judging domestic U.S. events. A foreign brevet judge will not be allowed to judge Levels 3-6 of the Junior Olympic Program. They may judge technical faults only for Levels 7-8.

J. Proposal regarding a Foreign Brevet Judge invited to judge and attending <u>without a competitive</u> <u>athlete representing their club</u>). A meet director will be allowed to invite a foreign brevet only when approved by the Rhythmic Program Director and the initial invitation and contact is made directly through USA Gymnastics.

K. Proposal for all unaffiliated judges to be given the opportunity to judge a minimum of one State, Regional or invitational meet within her region each cycle to ensure her active status or fulfill her requirements for mobility.

L. Proposal to require all judges regardless of Level or ranking to submit their judges log to the National Judges Representative on or before December 1st of each year.

Discussion occurred about the role/position of Regional Judging Coordinators, the possibility of this becoming an elected position, the need to abide by the Operating Code when assigning State and Regional events and issues related to a meet directors' interference in judging assignments.
