 - 4. Only return D forms after the final award ceremony

Recommendations to RPC:

- 1. Proposal to include branding information in the R&P
- 2. Proposal to amend the term of service for the National Judges' Representative, to a four (4) year term.
- 3. Proposal to allow the National Judges Selection Committee to assign the level 7/8 meet referee for each Regional Championship

- 4. Proposal to allow the top 20% of Level 9 Junior and top 20% of Level 9 Senior competitors at the National Qualifier/Level 9 Championships to become Level 10. Qualifiers to the National Championships will become Level 10 Elite.
- 5. Proposal to separate Level 9 Championships from the National Qualifier in 2017
- 6. Proposal to recognize any athlete who becomes level 10 with a certificate from USA Gymnastics
- 7. Proposal to allow judges who have been unable to fulfill the requirements to maintain a rating due to extenuating circumstances to submit a petition the National Judges Representative.
