1. Welcome

2. 2024 Cottbus World Cup

The Committee read through the [Olympic Qualification World Cups Selection Procedures](#). In adherence to the posted procedures, the selection committee ([On August 14th, 2023](#)) voted to select Nicole Ahsinger, Jessica Stevens, Ruben Padilla, and Alexi Shostak for assignment to the 2024 Cottbus World Cup. This leaves 2 male and 2 female spots remaining plus a non-traveling alternate spot for each still needing to be named following the Baku World Cup. The Committee reviewed the score rankings for the remaining athletes and verified the [Olympic World Cup Athlete Ranking](#) spreadsheet. As the National Team Coordinator, Nuno presented recommendations for the remaining Cottbus athlete positions based on the rankings document. Discussion was had to make sure that all options were fully considered.
