1. 2019 Judge Assignment Recommendations

There was discussion regarding assignments for judges to 2019 international events. The following recommendations were agreed upon, with World Championships and World Age Group Championships to be discussed later in the year once the 2020 international calendar was more known.

February 13-17 Baku World Cup (Group 1 Competition, Cat 1 or 2 judges)

April 17-21 Minsk World Cup (Group 1 Competition, Cat 1 or 2 judges)

- Trampoline: Tatiana Kovaleva (Backup: Konstantin Gulisashvili)

August 2-5 Pan American Games, Lima (Group 3 Competition, Cat 1-3 judges)

- Trampoline: Konstantin Gulisashvili (invited by PAGU), Bob Hallwig

September 18-22 Russia World Cup (Group 1 Competition, Cat 1 or 2 judges)

- Trampoline: Konstantin Gulisashvili (Backup: Tatiana Kovaleva)

October 2-6 Valladolid World Cup (Group 1 & 2 Competition, TRA Cat 1 or 2, TUM / DMT Cat 1-3 judges)
