# 1. DMT Representative Replacement

Jenae Ashbrook has resigned from the Technical Committee DMT Rep position. The committee acknowledged Jenae's contribution over many years and thanked her for her hard work.

Per the R&P, the TC should now appoint a replacement for the duration of the term (1 year remaining), subject to the approval of the Program Committee. The replacement must meet the requirements of the role:

Criteria for nomination: (Must meet all of either bullet):

- Be a USA Gymnastics Professional Member, actively involved in the program, at least 21 years old, and in good standing for at least two (2) consecutive years prior to the nomination. AND hold an FIG Brevet in the discipline he/she intends to represent within the current or last quadrennial cycle.
- Be a USA Gymnastics Professional Member, actively involved in the program, at least 21 years old, and in good standing for at least four (4) consecutive years prior to the nomination AND hold a Judges Category 1 in the discipline he/she intends to represent within the current or last quadrennial cycle.

The committee determined that the successful candidate should have judging as their primary role. They eliminated active coaches and athletes from consideration, discussed all remaining candidates, and ranked their top choices. Deanna will approach the top candidates in order of ranking to determine their willingness to do the role.

Motion to accept the ranking of candidates as discussed and proceed with assessing potential candidates' willingness to do the role.
