



2027 Trampoline & Tumbling Selection Event Bid Information

If you are interested in hosting a 2027 USA Gymnastics Trampoline & Tumbling Selection Event, bids must be received by January 6th, 2025. Please send bids to T&T Program Director Amanda Casale at acasale@usagym.org.

Requirements:

- The 2027 Selection Event should be conducted in conjunction with an invitational, state or regional event. The preferred weekends are:
 - March 4-6, 2027 (preference)
 - February 25-27, 2027 will also be considered
- The 2027 Selection Event will include the following divisions, in Trampoline, Tumbling and Double Mini Trampoline (additional divisions including YE 11-12 and Development Levels may also be included within the related event):
 - Youth Elite 13-14, Girls & Boys
 - Junior Elite 15-16, Girls & Boys
 - Intermediate Elite 17-21, Men & Women
 - Senior Elite 17+, Men & Women
- The logo for the event may not contain the USA Gymnastics logo. However, USA Gymnastics will provide a tag that must be included with the invitational logo that designates the invitational as a Selection Event. The logo must be approved by USA Gymnastics.
- The host will collect entry fees of \$150 entry fee for each elite competitor regardless of the number of events on which they compete. The host may decide to refund an athlete with proof of injury.
 - The host will pay USA Gymnastics 5% of the total entry fees to go back to USA Gymnastics Trampoline and Tumbling.
- All expenses associated with the competition will be the responsibility of the host. In addition, the host must pay expenses (flight, hotel, rental car, food) for one USA Gymnastics approved representative to be on hand during the competition to oversee the event.
- Competition dates and site must be approved by USA Gymnastics.
 - Facility must meet R&P requirements for length and ceiling height.
 - Seating must be appropriate to accommodate spectators
- Final competition schedule must be approved by USA Gymnastics. In addition, any changes must be approved by USA Gymnastics.
- Final floor layout must be approved by USA Gymnastics.
- The directives for the event must be approved by USA Gymnastics.
- All elements of the event must comply with the T&T R&P, USAG Sanctioned Event requirements and all other requirements as applicable.
- The meet director for the event must work closely with USA Gymnastics to ensure that the event is conducted in a manner that best represents USA Gymnastics and respects the level of competition.
- USA Gymnastics retains the exclusive rights to broadcast the event via any and all mediums. In the event that USA Gymnastics, or its designee, choose not to broadcast the event and the event host desires to broadcast the event, the host must receive written authorization from USA Gymnastics prior to entering into a broadcast agreement.
- Scores must be displayed to athletes, coaches and spectators after each pass, either manually or electronically. Score display must include the following:

- Trampoline: Time of Flight / Difficulty / Total score for pass one and total score after pass two
- Tumbling: Difficulty / Total score for pass one and total score after pass two
- Double Mini: Difficulty / Total score for pass one and total score after pass two
- Scores must also be made available either online or onsite for the duration of the event.
- The host must work with the T&T Technical Chair and T&T Program Director to select judges for the event. The requirements must be met as it applies to the judges:
 - All Selection Event panels will be selected and seated by the T&T Technical Chair and both the T&T Technical Chair and T&T Program Director must approve any changes.
 - The judging panel size and configuration must meet the requirements listed in the Elite Code of Points.
 - All travel expenses for Selection Event judges must be paid by the Host.
 - Judges must be paid by the Host in accordance with the "Minimum Pay Scale" found in the T&T Rules & Policies. Equipment must be FIG-approved and meet the current apparatus norms provided by the FIG.
- The host must use JTeam travel for all hotel needs.
- The host must use USA Gymnastics approved equipment.
- In the case that a non-USA Gymnastics managed Selection Event is not included in any of the 2027 Trampoline & Tumbling Selection Procedures, USA Gymnastics has the right to cancel this contract at no expense or penalty to USA Gymnastics and the host would have no right to use the term "Selection Event" with regards to their competition.
- Host must use USA Gymnastics merchandise provider for any t-shirt / merchandise sale unless USA Gymnastics declines. Revenue will be shared as follows:
 - Event-Specific Merchandise
 - If total sales are less than \$50,000, Host will receive 30%.
 - If total sales are between \$50,000 and \$100,000, Host will receive 35%.
 - If total sales are more than \$100,000, Host will receive 40%.
 - Gymnastics National Product (not Event-Specific / USA Gymnastics Branded)
 - Host will receive 10%
