1. Vegas Cup – January 17-19, 2025, Las Vegas, NV
 2. Pikes Peak Cup – January 24-26, 2025, Colorado Springs, CO
 3. Buckeye Classic – January 30 – February 2, 2025, Columbus, OH
 4. Dragon Invitational – February 7-9, 2025, Kansas City, MO
 5. Metroplex Challenge – February 14-16, 2025, Fort Worth, TX
 6. KPAC Cup – March 13-16, 2025, Winston Salem, NC

- C. Clarification – One-day scores in the AA are taken into consideration by the Athlete Selection Committee for placement on the NT from U.S. Championships.
- D. Recommendation that Winter Cup be utilized as a qualifier to the National Team.
1. Junior National Team members aging up to the Senior age division must re-rank at Winter Cup to earn placement on the Senior National Team. Up to ten (10) senior athletes may be added at Winter Cup. Additional athletes may be added to the National Team from designated selection events.
 - a. Any junior athlete who achieved an All-Around score at U.S. Championships falling within the range selected for Senior National Team will be automatically named to the Senior National Team on January 1 of the following year.
 2. U.S. National Team NCAA athletes will be excused from National Team Camps scheduled between the conclusion of World Championships and the conclusion of NCAA Championships. To maintain U.S. National Team Status during this time;
 - a. The athlete must Zoom verify with the HPLT within one week before or after the scheduled National Team Camp and;

 - ii. One (1) Backward skill of your choice—choose ONE: May rebound, run out, or stick any.
 1. Round Off, Back Handspring, back tuck
 2. Round Off, Back Handspring, back layout
 3. Round Off, Back Handspring, back layout full
 - iii. One (1) Leap of your choice—choose ONE: Chasse or run approach:
 1. Split leap
 2. Switch leap
 3. Tour jete
 - iv. One (1) Full Turn of your choice—choose ONE:
 1. Passe Turn
 2. Leg Horizontal Turn
 3. Leg Hold Vertical (Y-Turn)
5. Fall 2024 Physical Abilities Testing Dates
 - August 3, 2024
 - August 17, 2024
 - September 28, 2024
 - October 5, 2024
6. October 19, 2024— National Skill Testing via Zoom, evaluated by National Team Staff.
