- **2.** Discussion regarding the Women's Program Service Award. Tom asked for input from the Regional DP Chairs. Please send all suggestions to Christy Naik.
- **3.** Discussion regarding the possibility of changing any mobility rules/scores from level to level with the new compulsories. No action at this time, as the committee agrees that the first year needs to take place before changes can be considered.
- **4.** Discussion regarding the opportunity for athletes to "skip" a level with the new compulsories. The current processes will stay in place, with athletes only able to "skip" level 6 with a 32.00 All Around score achieved in Level 5.

All of the following clarifications and recommendations for change are effective August 1, 2021, unless otherwise stated.



**5.** Revised October 1, 2021: Recommendation to amend *Women's Rules & Policies*, page 80.III.C: Any gymnast who has had previous competitive experience in any system other than USA Gymnastics but including USA Gymnastics Xcel athletes, and who is a minimum of 12 years of age is eligible to petition for entry into Level 7 and below by submitting a formal written request to the State Administrative Committee. The petition must be accompanied by a video that demonstrates her skill level.

**6.** Recommendation to update procedures for determining age divisions for Levels 9 & 10: Only regional qualifiers who achieve the minimum qualifying score to Eastern/Western Championships or Dev Nationals at State Championships will be included in age determination. Individual Event Specialists and petitioned gymnasts will NOT be included.

- **7.** Recommendation to amend *Women's Rules & Policies*, page 89.H.2.b: If any region is unable to field a team of seven gymnasts per age divisions, the open slots will be filled using the following formula:
  - Region with the largest number of gymnasts in that particular age division will fill the first open slot.
  - Region with the next largest number of gymnasts in that particular age division will fill the second open slot.
  - Region with the next largest number of gymnasts in that particular age division will fill the third open slot.

IF a fourth slot is open, it will return to the region with the largest number of gymnasts in that particular age division.
