Unless otherwise noted, the following clarifications and recommendations for change are effective for the 2023-2024 season, scheduled to begin August 1, 2023.

RULES & POLICIES (R&P): Recommendation to the National Administrative Committee to add:
Coaches and Judges shall NOT wear Earbuds / EarPods while on the field of play. Athletes may NOT wear
Earbuds / EarPods while competing.

2. **R&P**: Recommendation to allow IES (Individual Event Specialist) athletes to petition to Level 9 or 10 Regionals with an event score that is at least 0.25 greater than the current Regional qualifying score.

3. R&P: Recommendation for Uneven Bars that chalk or water may not be added to the rails or mats once the exercise has begun / while on the competitive equipment.

4. R&P: Recommendation to add under scoring: At a State meet and above, a Meet Referee has the authority to allow a judging panel to review a routine to verify that Special Requirements were fulfilled and restricted elements were not performed.

5. **R&P**: Recommendation to add under Inquiry regulations: Any inquiry to raise a score .10 or less on the lowest event score to qualify to the State or Regional meet applies ONLY to All Around athletes. It cannot be used at Regionals to qualify to East/West or Nationals, nor does it apply to IES.

6. R&P: Recommendation to add: A Meet Referee may watch a video (if available) prior to the submission of an inquiry to determine if that inquiry should move forward.

7. **R&P, OPTIONAL CODE OF POINTS (COP) - VAULT**: Recommendation for Levels 6-10 to require Vault numbers to be visually displayed at any sanctioned competition utilizing a 4-judge panel. Vault name OR number may be audibly communicated to judges at all other competitions.

8. COMPULSORY BOOK - FLOOR: Recommendation to allow either a tuck or pike entrance into the backward roll progressions in the Level 1-5 Compulsory Floor Exercises. Also, to amend the text to describe the option of a pike entrance and change the wording for the 0.30 deduction for "hands placed on the floor during the squat phase prior to rolling backward" to "hands placed on floor during the "sit" phase prior to rolling backward."

9. COMPULSORY BOOK - PENALTIES: Recommendation to add to Chief Judge deductions: No deduction for Coach standing between the Bars throughout exercise.

10. COMPULSORY BOOK, COP - VAULT / BARS / BEAM / FLOOR / GENERAL: Recommendation to update the language for squat on landing (hips lower than knees – up to 0.30) for landing positions on Vault, UB/BB dismounts, and BB/FX Acro elements, and amend the VT figures depicting squat on landing deduction.

11. COMPULSORY BOOK, COP - VAULT / BARS / BEAM / FLOOR / GENERAL: Recommendation to add an option for a 0.15 deduction for a medium step on landing on Vault, UB/BB dismounts, and BB/FX Acro.

12. COP - VAULT / BARS / BEAM / FLOOR: Recommendation to add wording to Vault, UB/BB dismounts, and FX Acro: Squat on landing (hips lower than knees) up to 0.30 + 0.50 "Lands in squat position, then falls".

15. *COP* - **BARS**: Recommendation for Levels 7 – 10 to accept the proposal for adding additional examples under COP-Bars page 13, d. with an approved chart for dealing with values of elements with ½ turns that finish on the same side of the bar (short side ½ turns).

- 16. COP BARS: Recommendation to add:
 - a. to BARS #2.205 element description: From cast in regular grip on HB, swing down with grip change to cross grip and ½ turn in range of hang position and swing backward in straddle or pike with flight over LB to hang.
 - an additional example of No deduction for insufficient amplitude of cast at Level 7 or 8 if cast is followed by #2.205.

- 17. COP BARS: Recommendation to rearrange Bars element box and add:
 - a. #8.107 b add a ½ turn to salto and move to B Element column, resulting in a new element #8.207 c.
 - b. #8.207 (now b) add to end of description "or from a counterswing".

- 18. COP BARS: Recommendation to change the value of the following elements:
 - a. #8.307 (C) From HB swing down forward between bars in reverse grip, salto forward tucked, piked, or stretched with 2/1 (720°) twist
 - \Rightarrow Change to #8.407 (D).
 - b. #8.407 (D) From HB—swing down forward between bars in reverse grip, salto forward tucked, piked, or stretched with 2 ½ (900°) twist
 - \Rightarrow Change to #8.507 (E).

19. *COP* - **BEAM:** Recommendation to add to description of Beam Mount #1.210 "or from cross handstand to front walkover exit". This mount variation would receive designation as a forward Acro element.

20. *COP* – **BEAM**: Recommendation to add variation of element #1.204 (B) – From rear stand (back toward beam), jump to clear straddle flight over the Beam to land in front support.

21. *COP* - **BEAM**: Recommendation to accept the sub-committee's suggested Beam mounts as designated forward/sideward/backward Acro skills. Designations will be included in the Beam elements section of the *COP*.

22. *COP* - **BEAM / FLOOR**: Recommendation for Levels 6-10 to add to the Beam and Floor Specific Element Technique Clarification section: Non-flight walkover-type elements are required to show 180° split of the legs at one point during the element.

23. COP - FLOOR: Recommendation to add to Floor element # 7.101: "A one-foot take-off will appear as an aerial/side salto but will NOT be considered a salto for Special Requirement or Composition purposes.

- **24.** *COP* **FLOOR**: Clarification for Level 7 Floor Exercise Special Requirements 1 & 2: A deduction of 0.50 is applied for any of the four specifications that are missing, up to a maximum of 1.00.
- **25.** COP FLOOR: Recommendation to remove the 0.50 deduction at Levels 6–10 for coach standing on Floor Exercise area (inside the border marking) during athlete's routine.

26. *COP* - FLOOR: Recommendation for Levels 6 – 10: Decrease the Chief Judge deduction on Floor Exercise for "Coach on the FX area (inside the border marking)" from 0.50 to 0.30.

27. COP - FLOOR: Recommendation to clarify on Floor Exercise that all forward and backward roll variations will receive an "A" Value Part, regardless of final position.

29. *COP* - **APPENDIX (FLOOR)**: Recommendation to remove the language "Non-salto Acro flight" from the Level 8 Floor Exercise composition chart for Value of Salto(s) performed as Last isolated salto or within the last Acro connection not up to the competitive level. (Appendix 15-page 4 in the *COP*).

30. COP VAULT / BARS / BEAM: Recommendation to add a deduction on landing for Vault and dismounts on UB/BB for "Failure to pause in control 0.05."

- 31. COP FLOOR: Recommendation to add to or change value of the following elements to the COP:
 - a. Add to #2.301 (C) "or 2½ (900°) turn"
 - b. #1.214 (B) 2nd element Hop with 1/1 (360°) turn, free leg extended above horizontal-take-off from one leg
 - \Rightarrow MOVE to #1.314 (C)
 - c. #1.314 (C): Hop with 1½ (540°) turn, free leg extended above horizontal-take-off from one leg
 - \Rightarrow MOVE to #1.414 (D)
 - d. #1.414 (D): Hop with 2/1 (720°) turn, free leg extended above horizontal-take-off from one leg
 - \Rightarrow MOVE to 1.514 (E)

b. **COP - BEAM**: Recommendation to accept the following new Beam element performed at 2023 Dev Nationals:

#2.501. (E) Rader: Jump with change of legs (minimum of 30° leg separation) and ¼ (90°) turn to straddle-pike or side-split in side position (180° leg separation) with additional ¼ (90°) turn to finish in cross position.

DISCUSSION - The committee discussed the following topics, but <u>NO ACTION</u> was taken:

- Lowering start values for L10 UB, BB and FX.
- 2. Procedures for timing FX routine when fall occurs.
- 3. Possible modifications to L10 UB & BB Bonus Principles
- 4. Execution errors taken after video review confirms judges missed an element/SR.
- 5. Under-rotation deduction on UB/BB dismounts, and FX Acro.
- 6. Possible deduction for delay in start of warm-ups.
- 7. UB warm-up time: possibly change to follow VT & FX/largest squad.
- 8. Consideration of different height expectations on UB for elements following a backswing.
- 9. Establishing principles for naming new elements and determining if it is a variation or a different element.
- 10. Consider changing time for athlete to start after green flag from :30 seconds to :10 seconds.
- 11. Level 10 only perform 1 Vault in competition.
- 12. Judges visually display compositional deductions.
- 13. Addition of possible notation system to Beam Group 2 and Floor Group 1 Elements (Leaps/Jumps/ Hops) to designate which elements are considered the same or different when multiple elements are listed under one number.
- 14. Floor Exercise Composition- Choice of Floor Acro (Salto) Elements Not up to the competitive level for 2 pass exercises at Level 9.
- 15. Floor Acro elements up to the level: 2 pass routine vs. 3 pass routines.
