

3. Update page 85 of the *Women's Rules and Policies* 2.b.1) to read: Any gymnasts who tie for 7th place will attend East/West Championships and will be outfitted as the other competitors. The tie-breaking procedures will be used to determine which gymnast's score will count for Regional team score and which will compete as an Individual. She will not be eligible to receive a Regional Team Award.



- 4. Discussion regarding athletes petitioning into the JO Program from the Elite Program. No change at this time. In addition to the current resources provided to coaches (*Women's Rules and Policies*), USA Gymnastics will put additional procedures in place to ensure that the process is clear to clubs.
- 5. Effective August 1, 2017, the following updated spring configurations for the springboard have been approved for use in USA Gymnastics sanctioned competitions:





6. Recommendation that for optional levels 6–10, there are three standard bar settings. Small, equivalent to the current FIG setting, medium, back (high-bar) slider set on two below five with the front (low-bar) spreader on "F", and large, back (high-bar)slider all the way down with the front (low-bar) spreader on "F". All standard settings would have even rails or the high bar one notch higher than the low bar. Motion: Brad Harris Second: Bryon Hough In Favor: 3 Opposed: 4 Abstention: 1

7. Recommendation to require a minimum of 3' in length of additional padding (carpet bonded foam or something similar), at the end of a 56' tumble strip that is used for warm-up.
