1. Code of Points (COP) - SAPPHIRE: Starting August 1, 2023, recommendation to implement the Sapphire Division rules into the Xcel Program as printed.

Rules & Policies (R&P) - VIDEO REVIEW: Recommendation to add in the Rules & Policies Page 68 after #5; In addition, at Xcel State Meet and above, a coach can request a video review by the Meet Ref and the highest rated unaffiliated judge (if video is available) in the event that the inquiry involved an instance that would affect the start value.

3.—DEDUCTION: Recommendation to remove the language Execution Deductions cannot exceed 4.0.

4. COP - DEDUCTION (CHIEF JUDGE): Recommendation to add a Chief Judge Deduction. Takes deduction from average score for Short Exercise with fewer than 3 value parts = 2.00.

5. COP - SPECIAL REQUIREMENT (BEAM/FLOOR): Recommendation to modify the split requirement for Platinum/Diamond (Floor) and Diamond (Beam) from 150° to 155°.

6. COP - ELEMENT (BARS): Recommendation to modify Uneven Bars element 8.101 - Underswing (toe-on or clear) to stand - Removing the Low Bar option. Add a new element for this dismount from the Low Bar - Allowable for Xcel Bronze or Silver only.

7. **COP - ELEMENT (BEAM):** Recommendation to modify Balance Beam element 1.109 to allow for a sit on the floor to do a back hip pullover to front support mount – change description to "from feet, knee or seat."

9. **COP - DEDUCTION (VAULT):** Recommendation to modify Vault deduction First Flight & Support Phase wording of "Arched Body up to 0.20" to "Excessive Arch Up to 0.20"

10. COP - DEDUCTION (VAULT): Recommendation to add Vault deduction for Gold - Sapphire for Support Phase - Hops with both hands simultaneously - <u>0.30</u>.

11. R&P/COP - VAULT: Recommendation to add Vault Warm-Up procedure for Platinum and above within the Code of Points and Rules & Policies (as applicable).

Warm-up procedures:

- a. Timed warm-up:
 - 1) During competition, it is NOT considered additional warm-up time if a gymnast who is next to compete on Vault runs or jumps on the Vault runway following the previous competitor's final Vault.
 - 2) The gymnast may NOT run or jump in front of the Vault judges' table.
 - A warning would be given in this instance for exceeding warm-up time.

b. Touch warm-up: Each gymnast is guaranteed a specific number of warm-up Vaults, depending on her Division.

12. *COP* - BARS: Recommendation to modify phrasing for Silver Cast angle to "Cast to a minimum of 45° below horizontal or higher."

- 13. COP BEAM/FLOOR: Recommendation that:
 - Non-flight walkover-type elements are required to show the split angle corresponding to the Division's degree of split at one point during the element for Beam and Floor.
 - Under Insufficient Split Position deduction add Non-flight walkover-type elements up to 0.20

14. COP - ELEMENT (BEAM): Recommendation to modify the Lever to touch beam (5.001) to require the free leg to be at horizontal or above.

COP - SPECIAL REQUIREMENT (FLOOR): Recommendation to modify the Diamond Special Requirement #1 on Floor to "Two (2) separate Acro Flight Passes, each with a minimum of two (2) directly connected Acro Flight elements; OR One (1) Acro Flight Pass with Two (2) directly connected Acro Flight elements AND One (1) separate/isolated "C" Salto."

16. COP - DEDUCTION (FLOOR): Recommendation to Increase the Floor deduction for "Poor relationship of movement and music throughout" from up to 0.20 to up to 0.30.

17. COP - SPECIAL REQUIREMENT (BARS): Recommendation to modify the Gold Bars Special Requirements 2 and 3 to:

SR 2/3. Two (2) 360° circling skills (not mount or dismount) must be one of the following:

- Two (2) directly connected same circling elements (performed on either bar); or
- Two (2) different circling elements connected or isolated (performed on either bar); or
- Two (2) of the same circling element; one performed on low bar and one performed on high bar.

18. *COP* - **DEDUCTION (GENERAL):** Recommendation to modify the Squat on Landing deduction and corresponding illustration.

Squat on landing (hips lower than knees) up to 0.30

- 19. COP ELEMENTS (VAULT): Recommendation to make the following changes for vault elements.
 - Current Vault 1.109 ¼ turn on ¼ turn off (to land facing away from the table) will be re-numbered to 1.108. No change in vault values.
 - Add the following vaults for Xcel

20. COP - ELEMENTS (BARS/BEAM/FLOOR): Recommendation to make the following changes to the table of elements.

Uneven Bars

• New Element - Tap Swing - ½, ½ dismount (twisting in one direction, touch of hand is required) - Allowable for Gold/Platinum Only as an "A" VP.

Balance Beam

- Add variation of element #1.204 (B) From rear stand (back toward beam), jump to clear straddle flight over the beam to land in front support
- Add variation of element #1.210 (B) Jump, press, swing to side or cross handstand also exit with walkover forward.

Floor Exercise

- Add variation of element #1.112 (A) Add Passe' hop 1/1 as a variation of element 1.112.
- Add variation of element #2.301 a 2½ (900°) turn on one leg (free leg optional)
- Raise 1.214 "B" Leg Swing Hop 1/1 to 1.314 "C"
 Raise 1.314 "C" Leg Swing Hop 1 1/2 to 1.414 "D"
 Remove Leg Swing Hop 2/1 (Previously a "D" this element is now an "E" in Development Program)

21. **R&P:** Recommendation for Uneven Bars that chalk or water may not be added to the rails or mats once the exercise has begun / while on the competitive equipment.

22. *R&P*: Recommendation to add regarding scoring: At a State meet and above, a Meet Referee has the authority to allow a judging panel to review a routine to verity that Special Requirements were fulfilled and restricted elements were not performed.

23. *R&P*: Recommendation to add under Inquiry regulations: Any inquiry to raise a score .10 or less on the lowest event score to qualify to the State or Regional meet applies ONLY to All Around athletes.

24. *R&P*: Recommendation to add: A Meet Referee may watch a video (if available) prior to the submission of an inquiry to determine if that inquiry should move forward.

25. *R&P, CODE OF POINTS (COP)* - VAULT: Recommendation for Divisions Gold - Sapphire to require Vault numbers to be visually displayed at any sanctioned competition utilizing a 4-judge panel. Vault name OR number may be audibly communicated to judges at all other competitions.

26. *COP* - VAULT / BARS / BEAM / FLOOR / GENERAL: Recommendation to add an option for a 0.15 deduction for a medium step on landing on Vault, UB/BB dismounts, and BB/FX Acro.

PASSED

27. COP - VAULT / BARS / BEAM / FLOOR: Recommendation to add wording to Vault, UB/BB dismounts, and FX Acro: Squat on landing (hips lower than knees) up to 0.30 + 0.50 "Lands in squat position, then falls".

28. COP - VAULT: Recommendation to change the deduction for under-rotation of salto vaults from a flat <u>0.10</u> to "Up to 0.10".

29. COP - BARS: Recommendation for Diamond and Sapphire to accept the proposal for adding additional examples under COP- Uneven Bars - Page 14/15 - #10 Letter d. with an approved chart for dealing with values of elements with ½ turns that finish on the same side of the bar (short side ½ turns).

- 30. COP BARS: Recommendation to add:
 - a. to BARS #2.205 element description: From cast in regular grip on HB, swing down with grip change to cross grip and ½ turn in range of hang position and swing backward in straddle or pike with flight over LB to hang.
 - b. an additional example of No deduction for insufficient amplitude of cast at Diamond or Sapphire if cast is followed by #2.205.

- 31. COP BARS: Recommendation to rearrange Bars element box and add:
 - a. #8.107 b add a ½ turn to salto and move to B Element column, resulting in a new element #8.207 c.
 - b. #8.207 (now b) add to end of description "or from a counterswing".

- 32. COP BARS: Recommendation to change the value of the following elements:
 - a. #8.307 (C) From HB swing down forward between bars in reverse grip, salto forward tucked, piked, or stretched with 2/1 (720°) twist Change to #8.407 (D).
 - b. Remove from Xcel #8.407 (D) From HB—swing down forward between bars in reverse grip, salto forward tucked, piked, or stretched with 2 ½ (900°) twist. This is now an "E" in the Development Program.

33. *COP* - FLOOR: Recommendation to add to Floor element # 7.101: "A one-foot take-off will appear as an aerial/side salto but will NOT be considered a salto for Special Requirement purposes.

PASSED

DISCUSSION - The committee discussed the following topics, but **NO ACTION** was taken:

- 1. Development of a judges course for Platinum, Diamond, and Sapphire.
- 2. Clarification that New Element Evaluation sheets are valid for only the athlete for which the element was submitted. Additional athletes wishing to compete the element will need to submit their own evaluation sheet to the Region Technical Committee Chair.
- 3. Platinum: Allow for one (1) 'C' Acro or Dismount that would count as a 'B.'
- 4. Bars: Coach lifting gymnast to high bar to begin the bar routine would be a <u>0.50</u> deduction for spot.
- 5. Modify Beam element 5.106 to add the partial handstand.

ACTION ITEMS

- 1. Update New Element Evaluation Form by removing instructions to post any new elements evaluated by the RTCC on the Regional website.
- 2. Xcel Code of Points:
 - a. Add Sapphire rules to the Xcel Code of Points.
 - b. Clarifications:
 - i. Add Clarification to the *Xcel Code of Points* that the order of Special Requirements within a routine does not matter.
 - ii. Floor-20 Clarifications regarding connections. Letter C. Remove Platinum/Diamond reference.
 - c. Appendix: Develop appendix materials for including judging sheets, shorthand cheat sheets.
 - d. Update the first page of the Table of Elements for Uneven Bars, Beam, and Floor referring to them as Additional A's. Will add to this page: :
 - i. Elements that are specific to Xcel which are open to all Divisions
 - ii. Any elements that are modified from the Development Program
 - e. Floor element 3.002 Update language consistent with the same element on Beam. Change wording to "feet together."
