- A. Women’s Rules and Policies, Chapter 3 page 26, E.9. Recommendation to add, “If a Meet Director incurs three sanction violations in one competitive season, he/she will be placed in pending status. He/she must re-take and pass the Meet Director Exam before being placed in active status.”
